



- New emissions inventory available. Passenger vehicles account for roughly 50%.

#### Soquel Dr Buffered Bike Lane & Congestion Mitigation Project

5.6 miles from Harbor High to Aptos. Estimated construction start: Dec. 2022 - Mar. 2023

- Bikes: 10+ miles of continuous protected or buffered bike lanes
- Pedestrians: 0.6 miles of sidewalk gap closures,
   11 enhanced pedestrian crossings with Rapid
   Flashing Beacons, 94 ADA ramp upgrades
- Adaptive Traffic Signals: Upgrades to 22 intersections with (ATS) and Traffic Signal Priority (TSP) for METRO

#### Scope

Pavement rehabilitation, new pedestrian crossings, buffered bike lanes.

#### **Schedule**

Construction starting this fall and completed this year.



### Highway 1 - Aux Lanes & Bus on Shoulder Project




Figure 1 - Phase 1 Project includes auxiliary lanes and a bus on shoulder facility in both directions of Highway 1 (41<sup>st</sup> Avenue to Soquel Drive), retaining walls, soundwalls, and a new bicycle/pedestrian overcrossing at Chanticleer Avenue



- Lift Line and Paracruz available for seniors and people with disabilities for medical transportation and meals on wheels




## Chanticleer Bike and Pedestrian Overcrossing

Question 1 has 147 answers (Radio Buttons)

"Do you support adding bike lanes to Thurber Ln between Helen Ave and Kenny Ave? This would require removing parking on the west side of Thurber. Parking would remain on the east side."

96 (65.3%)

No, keep parking

51 (34.7%)



#### More Traffic Safety Options in SC Gardens

#### **Suggestions:**

- Reduce speed limit from to 30 mph to 25 mph
   -> now possible thanks to AB 43
- Speed bumps -> defined process including signatures and cost sharing
- Stop sign at Helen and Thurber -> not advisable
- Buses to Santa Cruz Gardens Elementary -> no funding

**Next Steps:** neighborhood survey on speed bumps and speed limit.







#### Sustainability Update to the County General Plan

Goal: create 15 minute neighborhoods.

A 15-minute neighborhood is a neighborhood in which you can access all of your most basic, day-to-day needs within a 15-minute walk of your home. It is also sometimes called a complete neighborhood.

**Site specific goals:** create a community gathering space, new connections to Winkle Park, additional services like a market and coffee shop, and add housing for local workforce.


#### **Broadband - Work from Home**

- Board allocated \$500K grant awarded to Cruzio to install 20 wireless broadband access points.
  - 100 mbp/s speeds
  - \$74.95/mo Business and Residential
  - \$14.95/mo for low income residents
- First four installed with the Live Oak School District.
- Santa Cruz Gardens Elementary is a possibility for future projects.
- 2 prospective sites on Soquel Dr: Aldo's Building and Emerald Bay Apartments.
- County Broadband master plan underway to deploy State and Federal money as it becomes available





## Fire Safety



(Above) Private property - County has sent multiple letters out of encroachment and is pursuing further action through code enforcement.



Steps to become Firewise:

- Community Risk Assessment
- Prepare Multi-Year Plan
- Complete community education event
- Invest 1 hour or \$25 per household in risk reduction

There are now 36 Firewise communities county wide.
