### **FAA Flight Path Issue**

#### What's the status on Jet Noise?

- Met with Congressman Jimmy Panetta on April 29<sup>th</sup> about the FAA flight path issue.
- Reassured that the Select Committee's recommendation to move the flight path is still the guiding directive.
- Congressman Panetta and Congresswoman Eshoo reinforced that with the FAA Director when they met a few weeks ago.
- Lack of progress attributed to turnover in FAA leadership, communication issues within the FAA and the general challenges of working with the previous administration.





### **Cell Tower Status**

#### 7th Day Adventist Site

- This cell tower site is in litigation.
- Hearing was scheduled for April 26th at 8:30 am. but was postponed by the courts.
- New hearing date scheduled for June 17<sup>th</sup>.
- Case is against the County.
- Until this site is resolved, and the process becomes more streamlined to add towers, no towers are being planned for the Summit area.






### **Emergency Broadband Benefit**

#### FCC Announces Emergency Broadband Benefit

https://www.fcc.gov/broadbandbenefit

- The Emergency Broadband Benefit will provide a discount of up to \$50 per month toward broadband service for eligible families and households who are struggling to stay connected during the COVID19 pandemic.
- Eligible households can also receive a discount of up to \$100 for the purchase of a laptop, desktop computer, or tablet from participating providers.







### **Efforts to Expand Broadband**

#### **Planning for the Future**

- Board of Supervisors just approved \$500,000 to be used for expanding broadband access from funds received through the American Rescue Plan (ARPA).
- County staff will be issuing a Request for Proposals (RFP) from Internet Service Providers (ISPs) to deploy, operate and maintain an affordable broadband network for underserved rural areas.
- The County will offer up to \$500,000 to one or more applicants that commit to meeting the goals of the RFP.





### **Fire Updates**

#### **County of Santa Cruz, County Fire**

- Fire season is starting on May 17<sup>th</sup> which activates Level 3 staffing of 2 engines per fire station.
- Fuel moisture is checked twice a month. Current moisture is approximately 1.5 months ahead of normal levels seen at this time of year.
- There are currently no planned burns due to the moisture levels and fire conditions.
- They will present an updated state of the County to the Board of Supervisors in June.
- Requested new woodchipper in upcoming budget to help more residents reduce fuels



- Four camera locations were submitted to PG&E for prioritization and funding:
  - 701 Ocean Street County Building
  - Chanticleer Sheriff Center
  - Chalk Mountain (North Coast)
  - City of Watsonville Fire Station 2
- CalFire hopes to get cameras installed this year.






### **Evacuation Zones**

#### Know your Zone!

- Authorities in Santa Cruz County are using the evacuation management platform Zonehaven to establish zones.
- Zones are used in media releases to notify residents if there is an evacuation warning or order.
- Prepare now to be ready for a future event by finding your zone name for easy reference at <u>https://community.zonehaven.com</u>
- Your zone should be posted somewhere that is easily accessible for everyone in your household.





### **Firewise USA**

#### **Residents Working Together to Reduce Wildfire Risks**

- Becoming a Firewise Recognized Neighborhood is an important part of Wildfire Preparation in your neighborhood.
  - A neighborhood Firewise Committee applies for Firewise Recognition
  - Firewise USA will review your Wildfire Risk Assessment and your 3-year plan to Reduce Wildfire Risks
- Neighborhoods with a wildfire risk plan will be a priority for grants.
- 12 Firewise recognized communities: Las Cumbres, Riva Ridge, Marty Road, Terrace Grove, Sunset Ridge Road, Ellen Roads, Bird Streets, Tanglewood, Prospect Heights, Western Drive, Highlands and Paradise Park.





### Fire Funding for Mitigation Efforts State and County

- The new County division Office of Response, Recovery and Resiliency (OR3) is researching how they can obtain a portion of the \$536 Million allocated by Governor Newsom.
- OR3 is exploring as many different funding sources as possible for fire mitigation projects around the County.

### **Public Works Plan Public Hearing**

#### **Resource Conservation District of Santa Cruz County (RCDSCC)**

- RCD has issued a notice of Draft Public Works Plan for review and Public Hearing to occur on June 9th.

- Goal of the plan is to meet the need programmatic permitting for high-priority forest health and fuels management projects over the next ten years.
- Document is result of coordinated planning process of RCDSCC and San Mateo RCD, in collaboration with State Parks, Cal FIRE, CA Coastal Commission, and County from Santa Cruz and San Mateo Planning Departments.





## Minimum Fire Safe Regulations - "Substandard" Roads Board of Forestry and Fire Protection

- The 45-day comment period for the State Minimum Fire Safe Regulations, 2021 officially began on April 23, 2021, and ends at the close of the public hearing on June 22, 2021. Email comments, or comments as attachments to emails, are preferred. They can be sent to <u>PublicComments@bof.ca.gov</u>.

### **Homelessness and Homeless Camps**

#### **North Rodeo Gulch**

- Camps located on County property were removed
- Camps located on private property are being addressed. There is a trespass letter on file with one parcel through the Sheriff and a citation has been issued. Owners of the two other private parcels have been located and notified.
- Car parked near homeless camp is not considered abandoned because there is a male living in the vehicle, and it has current registration.
- If residents see homeless camp re-establishing or drug activity, report it to the Sheriff at their Dispatch 471-1121.





#### **Storm Repair Sites**


- Mount Bache Road
  - FEMA has now approved, and project is out to bid for construction.
  - Construction is anticipated to be completed by end of October.
- North Rodeo Gulch Rd 3.82, 4.31 and 4.94
  - Engineering is mostly complete, minor revisions may be needed depending on permitting.
  - Working on obtaining permits, once approved then will need right of way acquisition and authorization from Caltrans.





#### **North Rodeo Gulch**

- Public Works states that they work to keep a vertical clearance of at least 14 feet through these areas.
- Responsible for mowing vegetation between 4 to 8 feet from the sidelines/shoulders of the road. If vegetation is beyond those limits it is outside of regular maintenance performed by Road Operations.
- All North Rodeo Gulch was ditched in the Summer of 2019 and high ditch maintenance areas were also done in 2020.






#### **Soquel Drive**

- Most of Soquel Drive has improved with of curb and gutter. These drainage gutters generally don't require ditching.
- Road Operations run sweepers through these areas throughout the year to keep the gutters and bike lanes clean.

#### **Road Operations 2021 Paving Schedule**

- Roads that are listed as SP are skin patch projects where the old surface is not removed but is paved over.
- All other roads will have a grinder go over the road surface grinding off 2.5" of surface material and then pavement will be done.
