NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION
BLUE RIDGE TANK REPLACEMENT PROJECT**

Title: San Lorenzo Valley Water District's Blue Ridge Tank Replacement Project

Location: The project is the replacement of an existing water tank. The project is located in a rural residential neighborhood in the unincorporated community of Boulder Creek in Santa Cruz County, California. The project is located south and east of Blue Ridge Drive and north of Short Street. The Blue Ridge Tank site is located on Assessor Parcel Numbers 084-261-13 and APN 084-261-14. These parcels are contiguous and are 0.095 acres and 0.241-acres respectively. Regional access is provided to the proposed project site via State Highway 9 and Kings Creek Road. The lands surrounding the proposed project site are developed with single family residences. The proposed project site is developed with the existing water tank and associated utilities and infrastructure.

Project Description: The San Lorenzo Valley Water District (SLVWD) would be replacing the existing redwood 40,000-gallon Blue Ridge Tank with a new 160,000-gallon tank providing 120,000-gallons of effective storage located in the community of Boulder Creek. The existing tank is currently undersized and leaking. The proposed project would involve demolition and removal of the existing Blue Ridge Tank, electrical panel, and utility connections. Site preparation would involve grading and removal of nineteen mature trees (8 redwoods, 2 oaks, 8 fir and 1 madrone) to accommodate the larger replacement tank. The new 160,000-gallon tank would be craned into location. The utility and Supervisory Control and Data Acquisition system would be connected to the new tank, after which the tank would be placed into service.
