7.1 Update on COVID/Omicron Surge

Presented by Brenda Brenner, Senior Health Services Manager and Emergency Medical Services Administrator for the County

- Number of positive cases rose rising sharply starting last week
- Department Operations Center (DOC) activated at Level 1 (highest level); support requested from County Emergency Operations Center (EOC)
- Hospitals full; staffing crisis; seeking help from State and other agencies
- Medical Reserve Corp (MRC) has provided vital response throughout the pandemic; stepping up again now; vaccinations, skilled nursing, etc.
- Updates on messaging and data on santacruzhealth.org
- Other areas have seen fairly rapid decline in Omicron surge, hoping that will be the case here

 - City had been managing Bridge Street homeless encampment until people were offered vouchers and encampment was removed; now another encampment is developing nearby, outside of city limits

 - 10.3.1 COVID big topic and hurdle currently
 - State made it clear not to close schools; distance learning not an option at this time
 - State provided tests; not everyone tested timely
 - Seeing many cases and struggling with staffing
 - Focusing on excluding positive cases, testing, and vaccination; about 7,000 of eligible children are vaccinated
 - Working with Public Health for contact tracing
 - Inspire Diagnostics has locations at school sites and other county sites for testing and vaccination; also open to general community

New final application package was submitted on 1.28.2021 to align with 4 new National Priority Investment Justifications required by DHS/FEMA. Final approval now granted; Scheduled for Board of Supervisors agenda for acceptance and appropriations 01.11.21.
 - 10.4.3 FY 2021 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2024) award of \$341,759. Projects submitted in the CalOES has reviewed and provided feedback for amendment for project with required Investment Priority; Amended and complete application to be submitted by 12.31.21.
 - 10.4.4 FY2022 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2024) award to be announced. Further guidance from DHS/FEMA and Cal OES pending; initial application due January 31, 2022. Initial meeting of Authorized Body of 5 to review and make decisions about projects was convened 12.13.21.
