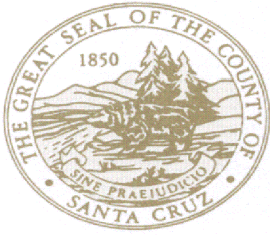

An update was also provided about the intent to submit an application to BSCC to receive Youth Programs and Facilities Grant Program Funding to support elements of the plan.

**B. Review Fully Populated Juvenile Justice Realignment Block Grant Annual Plan:** Probation Juvenile Division Director, Rob Doty, reviewed the plan with the group (Plan on file with staff) and invited input or suggestions before next meeting on May 18<sup>th</sup>. The Juvenile Justice Realignment Block Grant Annual Plan is to go to County Board of Supervisors on June 8, 2021.
