HE HEALTH SERVICES AGENCY (HSA) is comprised of five program areas: Environmental Health, Behavioral Health, Clinic Services, Public Health, and Administration. HSA is committed to providing services that meet the needs of the community, through health education, advocacy, planning, and clinical services designed to promote and protect the health of our citizens. HSA interprets and follows regulations implemented by the regulatory federal, state, and local agencies, and administers policy at the direction of the Board of Supervisors.

The Division of Environmental Health oversees a variety of programs and provides services that relate to the health and safety of people and the environment in the community. The office employs over 40 staff, including California registered environmental health specialists, water quality specialists, analysts, and support and technical staff. This team is committed to the protection of public health and the environment within Santa Cruz County through oversight, inspection, monitoring, permitting, investigation, enforcement, information management, education, and collaboration while providing excellent customer service. Its major program areas include consumer protection, hazardous materials/waste, site mitigation, land use, sewage disposal, wastewater management, and water resources.

the POSITION/IDEAL CANDIDATE

THE DIRECTOR OF ENVIRONMENTAL HEALTH IS a scientific and administrative professional who will oversee the activities of the Environmental Health Division within the Health Services Agency. While reporting to the Health Services Agency Director, this leader will oversee 40 plus staff, a budget of approximately \$14 million, and several ongoing projects and initiatives, including, but not limited to, consumer health protection, hazardous materials and site mitigation, land use, sewage disposal, waste water management and water resources. This is a high-level working position that requires a hands-on leader who will get to know their team and the community they serve. Due to the unique nature of the County's water system, this Director will oversee the Division's water lab and testing. They will also oversee Environmental Health Programs that include regulatory oversight of medical waste, body art, substandard housing, recreational water quality, and food safety.

The ideal candidate will be a thoughtful and trusted decision-maker who will serve as an energetic and approachable leader. They will have solid experience in environmental health and help the County move forward to meet the state's new standards of sewers. They will navigate political situations with ease and work alongside the Board, residents, developers, and other stakeholders. The Director will have the scientific rigor to interpret data and advance policy while demonstrating the interpersonal skills to communicate and plan with the community. They will be collaborative in nature and possess a willingness to listen to varying perspectives. The successful candidate will be diplomatic, responsive, and service-oriented. Someone who is a self-starter, partnership-oriented, and environmental justice conscious is highly desirable for this important position.
